The Veterinary Examining Board considered this matter at its meeting on June 13 2012.

BACKGROUND

On October 20, 2010, for the reasons stated in the Final Decision and Order of the same date, the Veterinary Examining Board limited Willard G. Janssen's veterinary license, number 321-50. The Order required him to pay costs in the amount of one thousand dollars (\$1,000.00) within ninety (90) days of the Order. Among other conditions, the Order required him to successfully complete the Wisconsin Veterinary Medical Association's record-keeping course and a minimum of two (2) hours of continuing education in the area of abdominal imaging/radiography.

The Order further required that he participate in a monitoring program under the direction of a veterinarian pre-approved by the Board. The Order required that the monitoring veterinarian review ten (10) medical records created by Dr. Janssen following the completion of the medical record keeping course. The Order required the monitoring veterinarian to review a minimum of five (5) additional records over the following 30 days to determine if Dr. Janssen was in compliance with the record keeping requirements of Wis. Admin. Code s. VE 7.03.

After April 12, 2012, Dr. Janssen submitted an undated letter petitioning for the removal of the above limitations from his license. On June 13 2012, the Veterinary Examining Board considered Dr. Janssen's petition to return to full licensure status. Based upon the information of record, the Board now finds and makes the following:

FINDINGS OF FACT:

1. On November 11, 2010, Dr. Janssen successfully completed the Wisconsin Veterinary Medical Association's record-keeping course.
2. On April 12, 2011, Dr. Janssen successfully completed a continuing education course in the area of abdominal imaging/radiography at the UW School of Veterinary Medicine, consisting of two and a half (2.5) hours.

3. Dr. Janssen paid his full costs on August 12, 2011.

4. Dr. Janssen obtained a Board approved monitoring veterinarian, Dr. Samuel Vainisi, who reviewed fifteen (15) medical records created by Dr. Janssen. Dr. Vainisi submitted a letter dated August 29, 2011, in which he found the medical records to be acceptable.

CONCLUSIONS OF LAW:

1. The Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 453.07.

2. Based on the record of this case and the findings outlined above, the Board concludes that Dr. Janssen is in substantial compliance with the requirements in the Final Decision and Order dated October 20, 2010.

ORDER

NOW, THEREFORE, IT IS ORDERED that Willard G. Janssen's petition to remove all conditions and limitations on his license and to reinstate him to full licensure status to practice veterinary medicine (license number 321-50) is hereby **GRANTED**.
